2.1. Recommended language skills

2.2. Additional requirements

- *Certificate of sexual offences*

In Spain for all those students who are taking the internship subjects must present the certificate of sexual offences in accordance with Spanish legislation, specifically the Organic Law 1/1996 on the Legal Protection of Minors, amended by Law 26/2015 and Law 45/2015, anyone who intends to work or volunteer regularly with minors in any capacity in Spain must submit a Sexual Offences Certificate (Certificado de Delitos de Naturaleza Sexual) issued by the Spanish Central Sex Offenders Register (Registro Central de Delinquentes Sexuales). The Sexual Offences Certificate provides proof that an individual has no criminal record of sexual offences or, on the contrary, indicates whether they have committed crimes such as sexual assault, abuse or harassment; indecent exposure; prostitution, sexual exploitation or grooming of minors; or if they have been involved in human trafficking.

This legislation applies to all students at the UGR who will be in regular contact with minors as part of their studies, internships or work placement. The Sexual Offences Certificate is the only valid certificate issued in Spain allowing students to work with children.

Foreign or Spanish citizens holding a second nationality must submit an official certificate from their country of origin or nationality proving that they have no record of sexual offences. This certificate must be translated and authenticated in accordance with current international agreements.

3.1. Grading system

In the Spanish university system, each course unit is graded on a scale from 0 to 10 points, and each numerical grade corresponds to a qualitative grade as follows: Suspenso (Fail): 0- 4.9 - Aprobado (Pass): 5- 6.9 - Notable (Good): 7- 8.9 - Sobresaliente (Very Good): 9- 10 - Matrícula de Honor: A special mention for outstanding performance limited to a maximum of 5% of students registered in a given course unit group. When a student does not take the corresponding examination or final assessment, this is reflected as No Presentado (Absent). To pass a course unit, a student must receive a grade of at least 5 points out of 10.
